4. All participants are expected to come with preparations and be ready & willing to be interactive during each and every session, not only by asking questions relevant to the topic of the session, but also responding to the queries put forth by faculties and dignitaries.
5. Stay arrangement of participants is made at Officers Hostel of Rajasthan State Judicial Academy, Near Jhalamand Circle, Jodhpur from 18 May, 2019 evening.
6. The lodging & boarding expenses of participant officers will be borne by RSJA. **Any request to accompany spouse/children will not be honoured.**
